Alderman William Russell took office as the 692nd Lord Mayor of the City of London on the 8th November 2019. He served as a sheriff of the City of

London in 2016–17 and, in that capacity, supported the then-Lord Mayor, undertaking numerous visits and official functions. On the 30th September 2020, he was elected to serve a further year in office to provide continuity of civic governance during the COVID-19 emergency. His second term began on the 13th November 2020.

Alderman William's mayoral theme for his time in office is 'Global UK – The New Future'. He was educated at Eton College and Durham University and has a strong family history with the City of London. He is the fifth member of his family to be Lord Mayor in the past 110 years. His grandfather, Sir Ian Bowater, was Lord Mayor exactly 50 years ago from 1969 to 1970 and his great grandfather, Sir Frank Bowater, was Lord Mayor from 1938 to 1939.

John Glen was appointed the economic secretary to the Treasury and city minister on the 9th January 2018. He was the parliamentary
