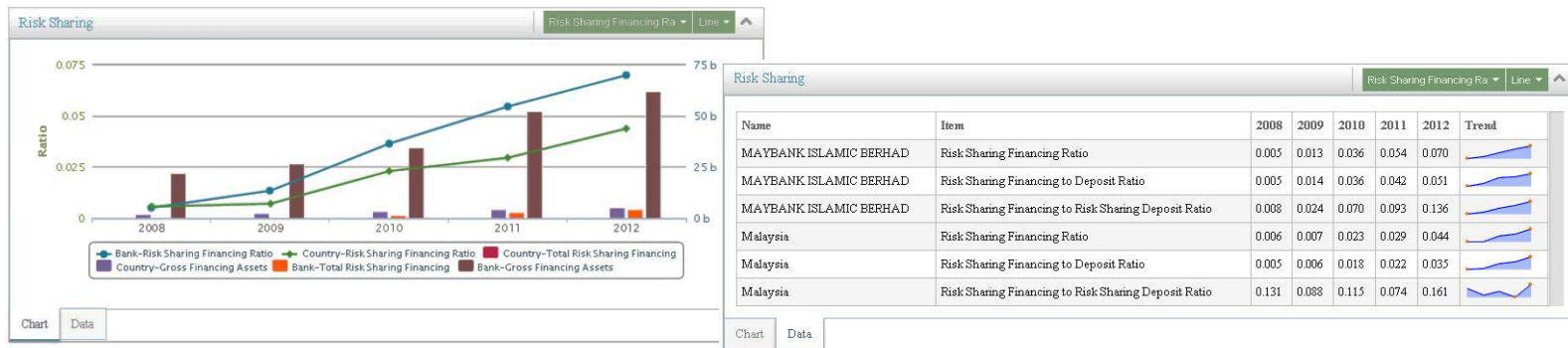


# What is IBI?

- IBI is accessible through an **annual subscription**



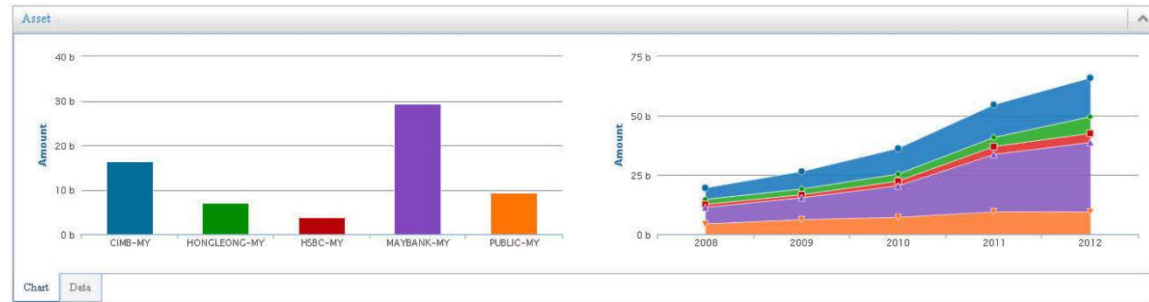

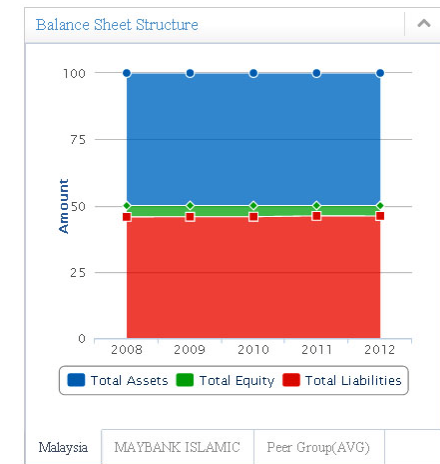
- As a truly innovative and analytical platform in the Islamic financial market, IBI ensures that data of global Islamic banks is **homogenous, comparable, and analyzable**

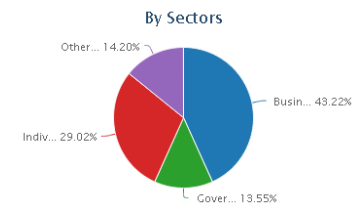
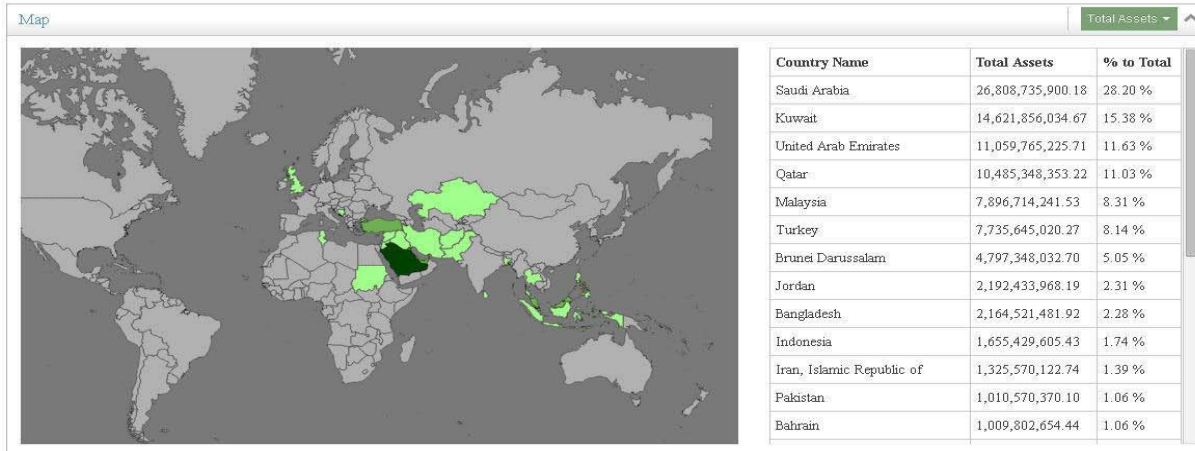
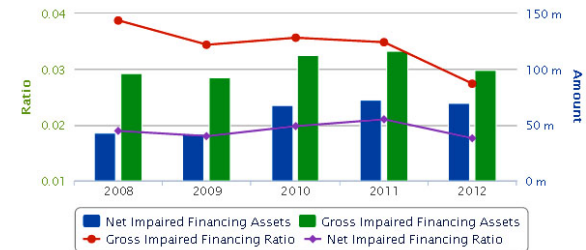
