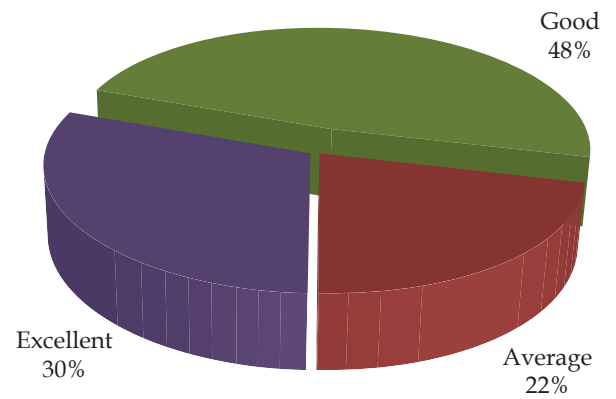

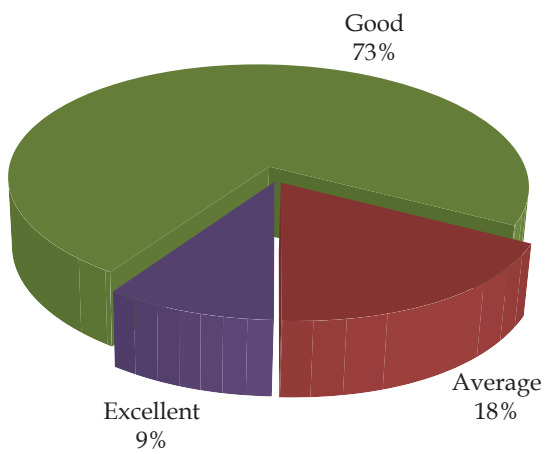

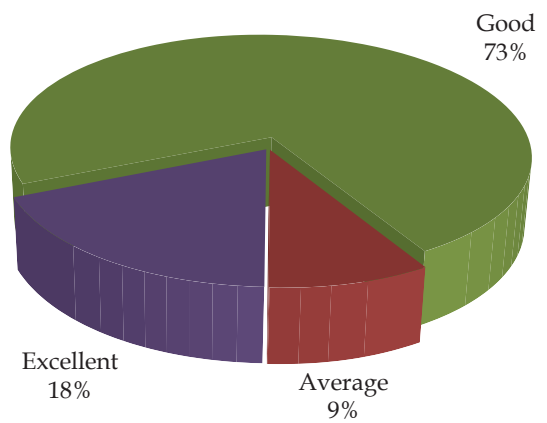

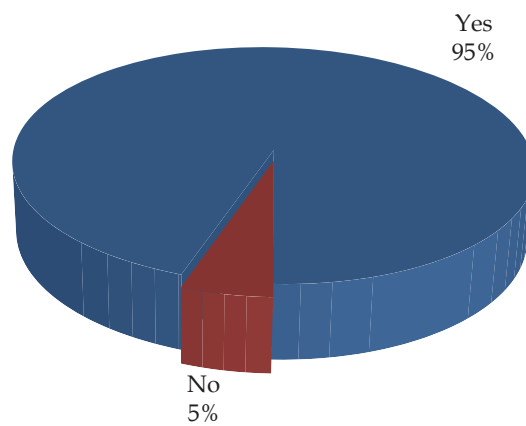
Overall Evaluation of the Event

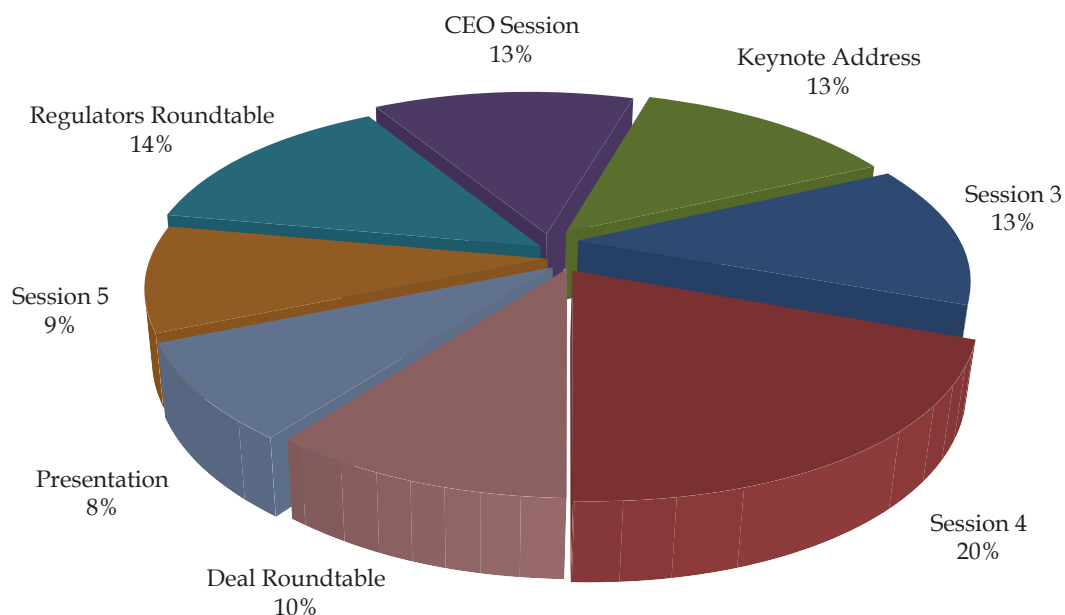

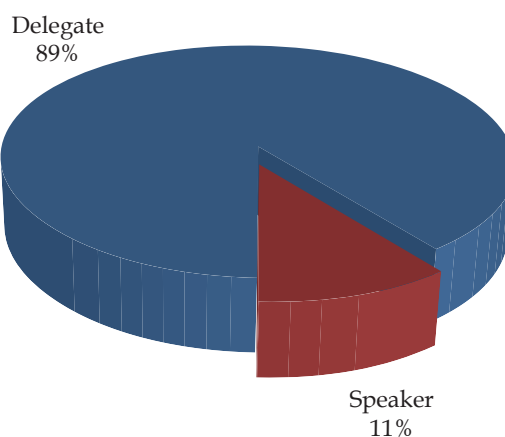

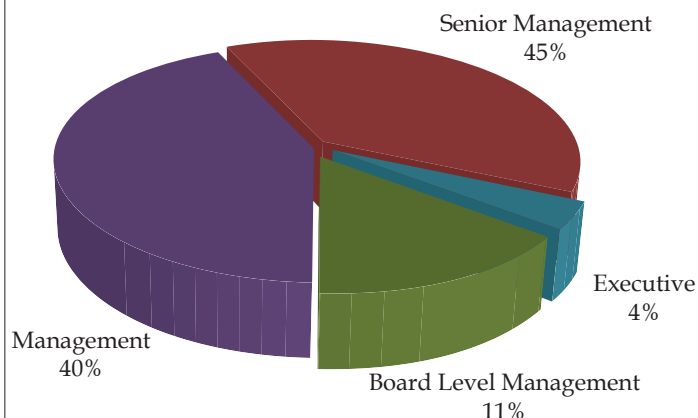
