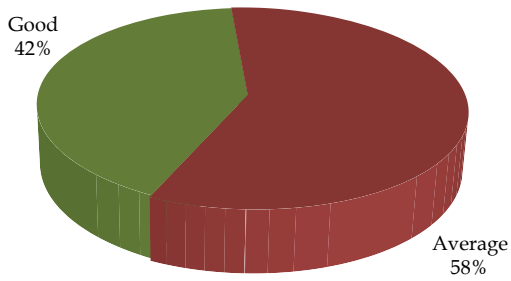

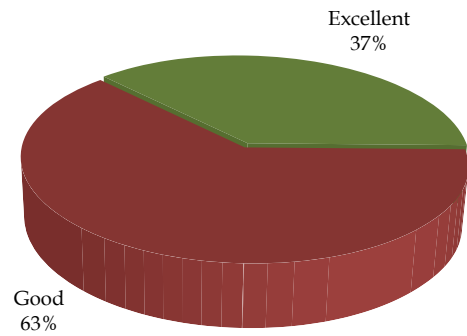

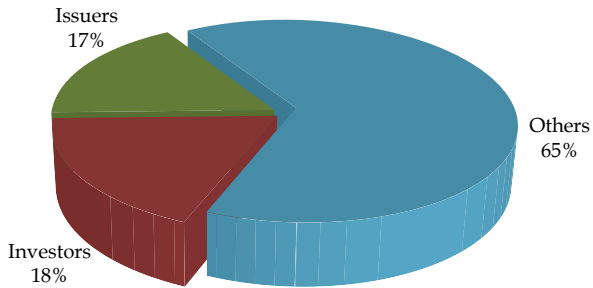
### Overall Evaluation of the Event



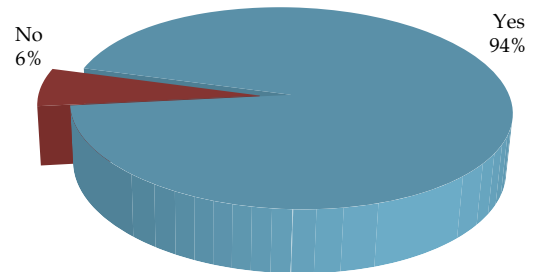

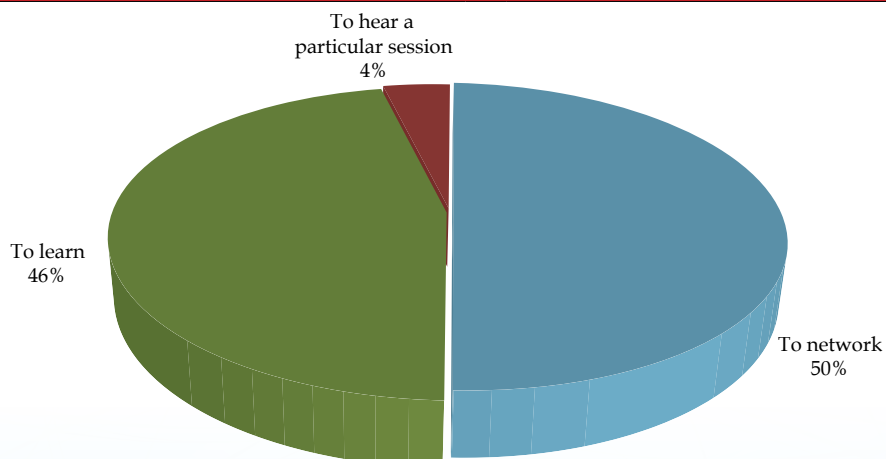
